The purpose of the Public Hearing Continuation was to hear comments on Introductory Local Law #3 of 2007, entitled "Sign Law Amendments."

Supervisor Dolan gave an overview of the revisions contained in the proposed local law and then asked for any comments from the public.

Ms. Dale Mottola read aloud her written comments and those of Mr. Gary Phelps objecting to certain portions of the proposed law. Copies of such comments are attached to these minutes.

Mr. Jerry Mottola read aloud his written comments in opposition to the law; a copy of his letter (excluding its attachment, which is available at the Town Clerk's office) is attached to these minutes.

Town residents Andrew Berish and Thomas Darling also spoke in opposition to certain portions of the law.

Supervisor Dolan asked for any further comments from the public. There were none.

In consideration of the comments made by the public, it was the consensus of the Town Board to modify the law accordingly, as specified in the resolution of adoption contained in the minutes of the regular meeting held immediately following this public hearing.
