The meeting was opened by a pledge of allegiance to the flag.

The purpose of the Public Hearing was to hear comments regarding Introductory Local Law entitled "Amendments to Towing Law."

Supervisor Dolan explained that the local law would amend Chapter 91 of the Town Code to provide for heavy-duty towing regulations.

Supervisor Dolan requested any comments.

Mr. Richard Sarajian, attorney for Loyal Tire & Auto, stated that he and his client have not objection to the concept of the proposed law but do not agree with certain provisions. His concerns include the gross vehicle weight rating for heavy-duty tow trucks, the definition of the word "winching," and the prohibition against charging for moving vehicles in storage. Although not in the proposed law, Mr. Sarajian also spoke at length regarding fees for heavy-duty towing licenses.

Supervisor Dolan requested any further comments. There were none.

Supervisor Dolan suggested that the public hearing remain open and the law reviewed in terms of Mr. Sarajian's comments.

**RESOLVED**, motion made by Supervisor Dolan, seconded by Councilperson Spivak, that the Public Hearing on Introductory Local Law entitled "Amendments to Towing Regulations" be continued until September 22, 2008.
