# TOWN OF TUXEDO INTRODUCTORY LOCAL LAW SUPPLEMENTAL REGULATIONS FOR ACCESSORY PARKING AND LOADING AMENDMENT

BE IT ENACTED by the Town Board of the Town of Tuxedo, Orange County, New York, as follows:

<u>Section 1.</u> Chapter 98 of the Code of the Town of Tuxedo, entitled "ZONING," is hereby amended by amending Section 97-17 entitled "Supplemental Regulations. Accessory parking and loading" to revise the required parking stall size and accessory parking and loading requirements for the Hamlet Business District. The section shall read as follows:

#### § 98-17 Supplemental Regulations

A. Off-street parking requirements. Off-street parking spaces open or enclosed, are permitted as accessory to any use, subject to the following provisions:

(3) Size of spaces. Three hundred square feet shall be considered one parking space, to provide room for standing area and aisles for maneuvering. Entrance and exit lanes shall not be computed as parking space except for driveways for one-family and two-family residences, as set forth in Subsection A(2). Minimum parking stall width shall be ten (10) feet; minimum length shall be twenty (20) feet, except within the Hamlet Business District, wherein the minimum parking stall width shall be nine (9) feet; minimum length shall be eighteen (18) feet, if the exemption provisions of subsection (H) are adhered to.

#### H. Exemptions.

- (1) Owners (or occupants with the owners' consent) of existing single-family and two-family dwellings, and existing commercial properties located only within the Hamlet Business District, may apply to the Building Inspector for an exemption from the requirements and standards of § 98-17.
- (2) In the event that a lot occupied by an existing single-family or two-family dwelling, or existing commercial property located only within the Hamlet Business District, cannot conform to the standards of § 98-17 because of lot size, configuration, and/or topography, as determined by the Building Inspector, such occupied lot shall be exempt from enforcement of the standard(s) which cannot be complied with, provided that such use does not violate the Building Code, Fire Code, or any other building or safety regulation that may apply.

### **Section 2.** Severability.

If any portion of this local law or the application of any other provisions to any item in this law is held invalid, the invalidity of that provision or application shall not affect any of the other provisions or the application of those provisions to other items in this chapter.

## **Section 3.** Supersession of Inconsistent Laws, if any.

The Town Board hereby declares its legislative intent to supercede any provision of any local law, rule, or regulation or provision of the Town Law inconsistent with this local law. The Town Law provisions intended to be superceded include any provision of law that the Town may supercede pursuant to the Municipal Home Rule Law and the Constitution of the State of New York. The courts are directed to take notice of this legislative intent and apply it in the event the Town has failed to specify any provision of law that may require supersession. The Town Board hereby declares that it would have enacted this local law and superceded such inconsistent provision had it been apparent.

### **Section 4. Effective Date**

This Local Law shall take effect upon filing with the Secretary of State.
