She and Councilmember Murphy have been working with Recreation Coordinator Claire Dougher on creating a Town calendar of events.
- Councilmember Reichgott said the Tuxedo Bag Project has been successful in collecting reusable grocery bags which are donated to the Sloatsburg Food Pantry. Drop off locations are Tuxedo Town Hall, Tuxedo Park Village Hall, Sloatsburg Town Hall and the clubhouse at the Woodlands.


