Supervisor English is in receipt of the following monthly reports:

Department Updates:

- Marisa Dollbaum, Town Clerk, announced the option of obtaining a 1-day marriage officiant license. The State now allows for a person to officiate a wedding ceremony for the cost of \$25.00. The person has to apply for that license in the same office that the couple applies for their marriage license. The Train Station RFP is posted and the bid opening is scheduled for Thursday, May 18th. The annual flower sale at St. Elizabeth's Chapel will start this Thursday. The Tuxedo Pollination Meadow group are meeting on Wednesday, April 24th at 6:30pm. The meeting will be held at the Tuxedo Library. St. Elizabeth's has a lawn sale on June 10th.
- Rob Dollbaum, Highway Superintendent, said the street sweeper will circulate through town for another two weeks. Repairs to the sewer lines continue and so far 95 feet have been replaced. A manhole on Mountain Road will be dug up and sealed to prevent the large amount of water that has been going in there. They purchased a camera with locator ability to help view inside of the sewer pipes. A portable flow meter was installed in one of the manholes to help measure the Town's inflow.

TOWN SUPERVISOR/TOWN BOARD UPDATE:

• Supervisor English met with Rob Dollbaum, Highway Superintendent, Deputy Supervisor Jay Reichgott, Town Engineer, Sean Hoffman, Bill Canavan, Environmental Consultant, and the DEC, Site Monitor, Wesley Salis. They discussed next steps in the remediation of the debris materials that have been processing for the last two years. The Town's goal is to try to avoid further expensive materials sampling while looking for beneficial uses for distributing the processed materials. Mr. Salis stated that he would take his findings to his supervisor and advise the Town of Tuxedo about our options for testing and disposal of the materials. Three applications for Hamlet Revitalization funds have been approved by the Tuxedo LDC Board. One of the applications approved was for Augusta Properties to rejuvenate a

property that is expected to attract a new restaurant and bring a coordinated aesthetic. The two additional projects approved were the Tuxedo Historical Society to restore the historic Chase Bank building and Karlin Realty LLC to restore a historic warehouse building in the center of the Hamlet Business District. All projects are funded under the 2022 Special Permit agreement with Related Companies which provided \$1,100,000 for Hamlet revitalization. He continues to coordinate the startup of the new sewer plant and the emergency actions needed to remediate the excessive infiltration of stormwater into the system. A \$62,400 agreement to begin the scoping work necessary to analyze the storm and groundwater infiltration into the Hamlet Sewer District's Collection system is now completed. A new vendor, Insituform, has been identified to begin lining the degraded sewer collection pipes in the Hamlet District. A scope of work and quote are expected next week. The Highway Department crew has replaced lengths of pipe on both Mountain Road and areas within Tuxedo Park that were determined to be in need of total replacement.

- Deputy Supervisor Jay Reichgott announced the start time of the Memorial Day Parade to line up is 11:00am and step off is 11:30am.
- Councilmember Michele Lindsay will meet with Senator Skoufis to discuss solar field opportunities,
 State funding for clean energy upgrades in Town Hall, solar roof for the Highway garage, and Route 17
 Road Diet to enable Streetscape projects. She is working on the community presentation on Pedestrian
 Safety and Connectivity with Councilperson Murphy that is scheduled for May 18th at 7:00pm. She will
 have table to represent the Climate Smart Task Force at the Community Fair on May 22nd hosted by the
 TUFSD.
- Councilmember May said summer camp is in planning process. A candidate was interviewed for summer camp recreation leader. She met with the Senior Committee and Chief Trazino to discuss need for senior citizens in Tuxedo. She announced a movie night sponsored by St. Mary's.
- Councilmember Murphy wrote a press release published in Photo News for the special meeting on May 18th. She met with Highway Superintendent Dollbaum in the Hamlet to measure and discuss sidewalks on Route 17. She has been in contact with NYSDOT about issues along Route 17, including oversized vehicles and options for sidewalks.
