2. Resolution Determining the Validity of a Petition for a Proposition to increase the 2023 Budgetary Allocation for the Tuxedo Park Library to be included on the November 2022 Ballot

Whereas Education Law §259(1) authorizes the Town to vote taxes for library purposes; and

Whereas the Town Board is the entity which can vote on such taxes unless the procedures for petition in subsection b(1) are implemented; and

Whereas the Town Board has received and reviewed a petition pursuant to Education Law §259(1)(b)(1), which Petition has been endorsed by the Board of Trustees of the Library; and

Whereas the Petition has been reviewed by Town officials

Now, Therefore, BE IT RESOLVED by the Town Board of the Town of Tuxedo, Orange County, New York, as follows:

- 1. The Petition is properly executed by qualified voters in excess of the total number of votes required by Education Law 259(1) as amended by L 2021 CH.70, (1) and has been properly endorsed by the Board of Trustees of the Tuxedo Park Library.
- 2. The Town Clerk is directed to forward an abstract of the proposition annexed hereto to the County Board of Elections so the same may be set forth on the ballot of the next general election of the Town of Tuxedo on November 8, 2022.

- 3. The Proposition shall read:
- 4. SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF TUXEDO FOR THE OPERATING BUDGET OF THE TUXEDO PARK LIBRARY BE INCREASED BY SEVENTEEN THOUSAND SEVEN HUNDRED SIXTY-EIGHT DOLLARS (\$17,768) TO THE SUM OF SIX HUNDRED THOUSAND SIX HUNDRED TWO DOLLARS (\$600,602) ANNUALLY
- 5. If such proposition is approved by the majority of the voters voting thereon at the general election, the amount so authorized shall be the budgetary appropriation for the next Town Budget adopted subsequent to such election pursuant to § 259(1)(b)(1).
- 6. The Town Clerk shall publish and post notice of the election at least 10 days prior thereto.
- 7. The Town Supervisor and Town Clerk are authorized to take all actions necessary and proper to carry out such election under law.

# TOWN SUPERVISOR/TOWN BOARD UPDATE:

- Supervisor English reported the NYS Division of Budget informed the Town that the remaining 50% of the American Rescue Plan Act funding will be \$152,307. Projects reported to date were the completed water treatment system that has been installed at the Highway Department that removes iron and manganese from the water making it both potable and usable for maintaining equipment. We also reported on the purchase of the Zoom Room equipment for Town Hall which, when installed, will allow the Town to hold meetings that provide fully interactive two-way communication with the public remotely. The A/V installation was stalled by supply chain issues but all equipment has now been received and the vendor is scheduling the setup with Marisa Dollbaum. Additional eligible projects are being considered by the Town Board. The final work for activating the Wastewater Treatment Plant is about to commence on July 11<sup>th</sup>. An updated timeline and completion plan is expected from Related. The Tichy Field Tennis Court/Basketball Court renovation project is moving forward. Demolition and paving have been completed and new draining has been installed. The court surfacing, line painting, fence installation, nets, backboard, etc. will be completed soon.
- Deputy Supervisor Lindsay has been reviewing the CCA Administrator bid submissions. She will make a recommendation to the Town Board to award a contract to one of the companies at the next meeting.
- Councilmember May said a survey will be sent out to seniors from the Office of Aging to see what services would be helpful to Tuxedo residents.
- Councilmember Reichgott said the Lucky Skate Park Cleanup Event was postponed and will be rescheduled soon. He announced the continuation of remote meetings by the Governor until August 14<sup>th</sup>.
- Councilmember Murphy said the survey of Long Meadow Rd. to reduce the speed limit is complete. A report from the County will be sent at the end of the month. She would like to reinstate the Parks and Recreation Advisory Board to get volunteers to help with Town events.

## **Department Updates:**

- Marisa Dollbaum, Town Clerk said the PBA BBQ Fundraiser on 8/13 will raise money to help spruce up the Tuxedo Dog Park. Officer Gundermann reached out to local businesses to participate and The Bark Club, USA Dog Shop and Tuxedo Pet Lodge will donate item to auction off to help raise money. There is another primary election on Tuesday, August 23<sup>rd</sup> because of the redisctring of Congressional lines. She will post a sample ballot once she receives it from Board of Elections.
- Robert Dollbaum, Highway Superintendent, said the road paving in Laurel Ridge is delayed because O&R will be placing new gas lines. The next roads that will be chipped seal are Benjamin Meadow and Warwick Brook Rd. They are screening material on the dirt pile on Long Meadow Rd.
