The objective of the "Tuxedo Paint Out" is "Discover Tuxedo" to introduce some of the most beautiful sites and scenes located within Tuxedo.

The Tuxedo Plein Air Event Coincides with Sloatsburg program.

Plein Air Event Outline

The event will invite artists to paint an array of pre-determined outdoor sites over a 2 day period. The objective to expose and educate the community on many of the hidden treasures within the Town of Tuxedo.

June 16 and 17 Painting on Site Days

June 18—Morning "Brush Up" and Hanging

June 18-20—Artist Reception and Exhibit – Tuxedo Train Station

June 18th Artist Reception 7pm-9pm

June 19 and 20 10 am-4 pm Exhibit hours (volunteer personnel to be present)

Program Details/Notes

Plein Air Event

Total of 25 sites to be designated. Sites to be marked with signage on Paint Out Days.

Themes will consist of:

- -Paint the Water -Rivers, brooks, waterfalls, lakes and ponds
- -Paint the Town-- various architectural sites thought the town and village to be pre-determined
- Paint the Landscape --meadows, mountains
- -Artists will pre-register and designate the spots they plan to paint.

Community participation will be encouraged through the use of an interactive map of Tuxedo designating sites with historical and pertinent information about the site.

Creation of a virtual map is an integral part of the program that can be used for future events to promote tourism.

-Promotion of the event through Social Media, the Website and Press Releases to Local Media

Registration and Artists Sales

Suggested registration fee \$25. Number of artists determined to be 25 based on the amount of space available for display in a gallery event. Registration to be administered through Eventbrite.

-Final event will feature an artist's reception where art is displayed and is available for sale. Tuxedo commission of 25% (this to offset costs and fund a future event)
