**RESOLUTION INTRODUCING LOCAL LAWS**  
**AND PROVIDING FOR PUBLIC NOTICE AND HEARING**

BE IT RESOLVED that the introductory Local Laws, entitled “Opt-Out of Allowing Cannabis Retail Dispensaries and On-Site Cannabis Consumption Establishments,” “Opt-Out of Allowing Cannabis Retail Dispensaries,” and “Opt-Out of Allowing On-Site Cannabis Consumption Establishments,” which local laws would opt-out the Town of Tuxedo from the state statute authorizing towns to allow the licensing and establishing of, respectively: (1) both cannabis retail dispensaries and on-site cannabis consumption establishments within the Town; (2) only cannabis retail dispensaries within the Town; and (3) only on-site cannabis consumption establishments within the Town; and thus prohibit such establishments in the Town of Tuxedo as stated, be and it hereby is introduced by \_\_\_\_\_, before the Town Board of the Town of Tuxedo in the County of Orange and State of New York, and

BE IT FURTHER RESOLVED that copies of the aforesaid proposed local laws be laid upon the desk of each member of the Board; and

BE IT FURTHER RESOLVED that the Board shall hold public hearings on said proposed local laws at the Town Hall, 1 Temple Drive, Tuxedo, NY 10987 at \_\_\_\_\_ P.M. on July 26, 2021; and

BE IT FURTHER RESOLVED that it is the intention of the Town Board to hear from the public at said public hearing to determine which of the three local law versions, if any, should be adopted; and

BE IT FURTHER RESOLVED that the Clerk publish or cause to be published a public notice in the official newspaper of the Town of Tuxedo of said public hearings at least five (5) days prior thereto.
