I seem to recall another reason for this proposal was to help protect against larger developments or creation of another village within the town or something to that affect. Do I have that right,

To all Board members and our town supervisor Ken English.(please distribute)

The pipe line is still viable if the price of fuel remains high or future events push demand and price per barrel making the concept of the pipeline down the Thruway through our township viable AGAIN. I WAS QUITE INVOLVED AND HAVE MUCH KNOWLEDGE AS I GOT THE INFO ORIGINALLY FROM A STATE SENATOR ABOUTT THE PIPLELINE GOING THROUGH Tuxedo as well as the School site and Tuxedo Reserve lands. The Related co. and Andrew Dance kept this info from all of us and the school district.

FYI the agency (NYS Transportation authority I believe it was called?), that proposed the pipeline was a state sanctioned private entity with <u>Condemnation powers. !!!</u> NYS and the thruway authority allowed them to use the center median of the NYS Thruway as you should recall, .

Being involved at the time and knowing our towns land and TPA lands, I found, located, suggested, and was instrumental in the TPA and the Related company with that Agency that had condemnation powers with the Pilgrim pipeline people agreed to give .an alternate location route for the pipeline and have an easement across the 60 acres the tpa donated to the town allowing the line to avoid the Tuxedo Reserve project. (Nick Sony and George Boynton Jr were with my

Partner Christian Sonne to sign off on the deal at our office 7 Park Ave on a Friday) I was there. Related started THAT NEXT Monday to clear their land again. Since then and before it Related company blamed the school for the reason they were not moving forward, but in reality it was the pipeline going through the middle of the project that held it up THAT TIME.. FYI Related never told the public or school nor the town when they knew, that the school proposed site, would have a pipeline of fuel oil and gasoline and would traverse the 40 acre school site related was to donate, clear and prep. Instead they without informing the school again, changed the lot line adding a ledge and taking away the buildable site, rendering it not buildable for a school site.

So here we are...again!

We should still become a Village to have controls and the state is not correct that the pipeline is not viable. If they want it it will happen.

This becoming a village was a process and community involvement with meetings and a vote. Now you want to change it with 1 skype meeting by the present board? What is it we do not know?

This is not open government!

I have tried to call the supervisors office and stopped by. No response.

I urge you not the change this Village status as I thought it was already DONE, WITH OUT THE COMMUNITY FULLY BEING ON BOARD, WITH SUCH A LARGE PROJECT ON THE HORIZON, WE NEED TO UNDERSTAND THE REASONS FOR THIS CHANGE OF DIRECTION AND PLAN FROM OU TOWN LEADERSHIP.

We also deserve a public hearing before you change a law with such potential impact and to be fully informed other than a pdf notice on a Friday in July.

Agenda Items:

1. Resolution regarding the dual incorporation and consolidation proceeding of the Village of Tuxedo

Whereas pursuant to the N.Y. Government Reorganization and Citizen Empowerment Act (Article 17-A of the General Municipal Law ("GML")), the electorate of the Town of Tuxedo therefore determined that 1) a new village, the Village of Tuxedo, should be formed with the same boundaries as the existing Town outside of the Village of Tuxedo Park, following Village Law incorporation procedures, and 2) that the new village should be immediately consolidated with the existing Town in accordance with a consolidation plan to create a town of Tuxedo with certain Village powers as set forth in the plan following GML Article 17-A Consolidation procedures. The consolidation proceeding was added to the village incorporation proceeding to avoid the overlapping governance structure of a Town of Tuxedo and Village of Tuxedo, which the public did not want to occur; and

Whereas the purpose of the proceeding was to allow for the consolidated Town entity to exercise specific additional village powers e.g., the prevention of certain infrastructure, including pipelines, from traveling through the Town's geographical borders pursuant to Village Law § 7-700, since the statutory power to exclude pipelines from the Town is a power that cities and villages possess, but not towns. In Tuxedo, there was town-wide concern that the proposed Pilgrim Pipeline would be sited in the most important undeveloped residential lands with the Town; and

Whereas, once the July 2019 referendum vote required for the dual incorporation and consolidation proceeding was approved by overwhelming majority vote, the Town Board was duty bound to act in accordance with their wishes and the mandate imposed by the favorable vote; and

Whereas the Town acted in accordance with the vote of the people taken in pursuant to the N.Y. Government Reorganization and Citizen Empowerment Act, and filed all required documents with New York State Department of State and the County of Orange as required by law; and

Whereas questions have arisen that the consolidated Town-Village entity is not permitted and the Village of Tuxedo dissolved upon the approval of the consolidation plan.; and

Whereas the Town does not want to (nor believes the electorate would support) expending the Town's limited financial resources in continuing to advance the validity of the consolidated entity in view of the fact that the resulting Town of Tuxedo with the enumerated Village powers in the Consolidation Plan is, at this point, a less costly means to achieve the same or similar goals.

Now, therefore, Town Board declares that the dual incorporation and consolidation proceeding failed in creating a Consolidated Town-Village entity and the Town of Tuxedo exists as a town with one existing village (Tuxedo Park); and be it further

Resolved that in accordance with the Consolidation Plan, approved by the electorate and the Town Board, the Town shall take all steps reasonable and necessary to prevent pipelines from being installed the Town of Tuxedo's geographical borders and to limit redundant government operations within the Town .

2. Resolution to approve sign permits – NY Renaissance Faire


