A public hearing regarding introductory Local Law entitled "REAL PROPERTY TAX EXEMPTION FOR VOLUNTEER FIREFIGHTERS AND VOLUNTEER AMBULANCE SERVICE WORKERS" was opened at \_\_\_\_\_\_pm by \_\_\_\_\_\_

The local law adopting the changes has been provided to the Board and is attached. The significant changes from the Town's existing law regarding this subject are as follows:

- 1. The exemption can now apply in situations where a portion of the property is not used exclusively for the applicant's residence but is used for other purposes. In such a case the exemption will apply only to the residence portion and the balance shall be subject to full taxation. Currently the property must all be used as the applicant's residence.
- 2. The enrolled member must be certified by the Chief of the Fire District to have served at least 2 years of active service rather than 5 years as now.
- 3. The 10 percent exemption is not subject to the \$3000 cap as now.
- 4. The exemption will now continue for the un-remarried spouse of an enrolled member of the Fire District who is killed in the line of duty upon the following conditions:
  - a. The un-remarried spouse is certified by the Chief of the Fire District as the un-remarried spouse of the volunteer firefighter killed in the line of duty; and
  - b. The deceased volunteer firefighter had been an enrolled member for at least five years; and
  - c. The deceased volunteer firefighter had been receiving the exemption prior to his or her death.
- 5. The exemption will now continue for the un-remarried spouse of a deceased member of the Tuxedo Joint Fire District under the following conditions:
  - a. The un-remarried spouse is certified by the Chief of the Fire District as the un-remarried spouse of the deceased enrolled member of the Tuxedo Joint Fire District
  - b. The deceased volunteer firefighter has been an enrolled member for at least twenty years
  - c. The deceased volunteer firefighter has been receiving the exemption prior to his or her death.

### ADOPTION OF THE NEW YORK STATE UNIFIED SOLAR PERMIT

**WHEREAS**, The Town has duly adopted the "NYS Fire Prevention and Building Construction" code to provide minimum requirements to safeguard the public safety; and

**WHEREAS,** The Code Enforcement Officer, who administers and enforces all provisions of the New York State Uniform Fire Prevention and Building Code, the New York State Energy Code, and the Tuxedo Town Code; and

**WHEREAS,** The Town requires the issuance of a building permit for the construction, enlargement, alteration, repair, removal or demolition of any building or other structure; and

**WHEREAS**, The New York State Uniform Fire Prevention and Building Code regulates the design, construction, installation, alteration and repair of equipment and systems using solar systems; and

**WHEREAS**, The New York State Energy Research and Development Authority has developed a New York State Unified Solar Permit that reduces the cost for solar projects by streamlining municipal permitting processes: and

**WHEREAS**, The Town desires to promote the streamlining of the application process for small-scale photovoltaic system installations under 25 kW in size by adopting the New York State Unified Solar Permit application form and implementing the new procedures,

**NOW THEREFORE, BE IT RESOLVED,** the Town Board hereby adopts the New York State Unified Solar Permit application form and procedures for the installation of small scale photovoltaic systems; and it is further

**RESOLVED,** the Code Enforcement Officer is hereby directed to use said New York State Unified Solar Permit application for and procedures in the issuance of building permits for the installation of small-scale photovoltaic systems; and it is further

**RESOLVED,** Any further actions required of the Town to effect the foregoing are hereby authorized and the Supervisor is hereby authorized to execute and deliver any instruments, documents or the like as required to effect the same.

## **DISCUSSION ITEMS**

1. ATM placed at Train Station (Tabled if Jay is not at the meeting)

ATM PLACEMENT AGREEMENT: This ATM LOCATION AGREEMENT is entered into and is effective this \_\_\_\_\_\_ of \_\_\_\_\_, 2023 between All County Vending ("ATM Owner") and the Town of Tuxedo\_ ("Town").

- Basic Agreement. It is hereby agreed that the ATM Owner is granted the exclusive right to securely install, maintain, repair and insure the ATM machine at the following single location, at no cost or obligation to the Merchant.
- Filling The Machine and Processing Fees. ATM Owner will fill the machine with cash and pay all processing fees.
- Telephone & Electrical Requirements. Town agrees if needed to provide a 110-volt power outlet, a telephone or internet access.
- Instillation & Maintenance. ATM Owner shall install or contract installation on the ATM. For insurance purposes the ATM must, may be bolted to the floor if needed. ATM Owner shall provide all labor involved with service and maintenance. ATM Owner shall respond to repair or service calls within a reasonable time.
- Signage. With the Town's permission the ATM Owner shall be allowed to erect ATM signage as necessary to attract ATM business, subject to the Town's sign regulations.
- Town Commission. In consideration for the right to place the ATM at the Town's designated location, All County Vending will Pay the Town\$.50 for each transaction commencing with the 26th transaction after installation. The Town will get a detailed report each month.
- Termination for Low Usage/Cause. The ATM Owner may end this agreement if, after a period of time, low usage is determined and keeping the ATM in the location does not justify continuing at the location. The Town may terminate this transaction at any time on 90 days written notice.
- ATM operator has the right to contract with a 3rd party for the maintenance and loading of the cash for the machine. ATM owner has the right to transfer or sell this agreement to any third party as long as the third party agrees and follows all the terms of the agreement.
- Term of Agreement 12 months. During which time no other cash dispensing machines may be used on these premises. This agreement shall automatically renew for the same time frame as the original term unless written notice is received by the ATM Owner 60 days prior to the ending date of the term
