### AMENDMENT TO THE

### MEMORANDUM OF UNDERSTANDING FOR THE CONSTRUCTION & OPERATION OF A NEW WASTEWATER COLLECTION SYSTEM AND SEWAGE TREATMENT PLANT

THE TOWN OF TUXEDO AND
THE TOWN OF TUXEDO ON BEHALF OF
THE HAMLET OF TUXEDO SEWER DISTRICT AND
THE TUXEDO FARMS SEWER DISTRICT

and

#### THE TUXEDO FARMS LOCAL DEVELOPMENT CORPORATION

and

#### TUXEDO RESERVE OWNER LLC,

and

#### TUXEDO SEWAGE-WORKS CORP.

A Memorandum of Understanding was signed May 11, 2015 (the "MOU"). The MOU was made among the Town of Tuxedo ("<u>Town</u>"), acting on behalf of itself and the Hamlet of Tuxedo Sewer District and Tuxedo Farms Sewer District; the Tuxedo Farms Local Development Corporation; Tuxedo Reserve Owner LLC, and the Tuxedo Sewage-Works Corp. This is an amendment to the MOU.

A Special Permit for the Planned Integrated Development now known as "Tuxedo Farms" ("**Special Permit**") was initially granted by the Town Board on November 15, 2004, and had been previously amended through November 22, 2010. The Town Board adopted a further amendment to the Special Permit on April 20, 2015.

By this amendment to the MOU, the parties recognize and incorporate into the MOU the amendment to the Special Permit adopted on April 20, 2015.

The wastewater treatment plant ("WWTP") is to be built in accord with the MOU, the Special Permit, the approved site plan, and other findings and regulations. On May 7, 2015, the site and architectural plans for the wastewater treatment plant ("Site Plan") were submitted to the Planning Board of the Town of Tuxedo ("Planning Board"), the Town's engineers, and others. The

approved Site Plan consisted of 28 drawings, all dated May 7, 2015, prepared by Delaware Engineering, DPC, and signed by Brock Juusola, P. E. A list of the drawings is attached.

In addition to all of the regulatory and statutory requirements, the Site Plan was intended to meet the requirements set by the Special Permit, the Planning Board, the Architectural Review Board of the Town of Tuxedo ("ARB"), and, to the extent applicable, the zoning laws. After review by its representatives, the Town is hereby waiving the local law requirement for a sprinkler system at the WWTP. Applications for a building permit for the construction of the WWTP will be in accord with the Site Plan and the Engineering Report incorporated into the MOU.

By this amendment to the MOU, the Town is incorporating the Site Plan by reference and recognizing that the Site Plan complies with the comments submitted by the Planning Board and that no further approval by the Planning Board, the ARB, and Zoning Board of Appeals is required.

On page 12, the MOU states that the Town shall pay the TransCo the assessment for the O&M Budget allocated to the Farms District. By this amendment, the parties agree that the Town shall pay the assessments to the Trustee and the Trustee shall pay the O&M to the TransCo.
