**The Public Hearing was next called to order on a Consolidated funding Application Grant (CFA)**

Deputy Supervisor Lindsay explained that she recently learned the Consolidated Funding process had been delayed due to CoVid-19, since the Public Hearing was already noticed she decided to go ahead with it. Deputy Supervisor Lindsay explained the 2019 CFA focus was to finding parking in the Hamlet Business District. They're applying for funding to expand the Town center study to come up with a plan making the Town more pedestrian friendly. Al Fusco the Town's Engineer will add preliminary drawings pertaining to the vehicle and parking laws changes recently addressed by the Town Board.
