The Town Board hereby adopts the proposed 2021 budget submitted by the Town Supervisor inclusive of all of the special districts and their assessments, as set forth in the budget document attached to this resolution.

This special meeting is necessary to make an adjustment to the Tuxedo Farms Sewer District special assessment. The assessment is set at \$2,026,000, a 1.7% increase from 2020, to be collected from parcels within the Tuxedo Farms district for the upcoming year, 2021.
