Supervisor English is in receipt of the monthly reports from the Justice Court, Building Department and Town Clerk.

DEPARTMENT UPDATES

• Marisa Dollbaum, Town Clerk, stated the eyeglass recycling collection will end on May 18th. She will be dropping them off to the Lion's Club with Tuxedo Park Library employee Ginny O'Neal. She received a permit application from the NY/NJ Trail Conference for the use of Powerhouse Park for a proposed trail race on July 31st. The park would be used as a staging area for the runners. Supervisor English instructed the NY/NJ Trail Conference to provide volunteers and two porta potties.

• Robert Dollbaum, Highway Superintendent, stated there are two bins of mulch, and one bin of compost at Quarry Field. He cautioned residents that the compost is hot. His crew is crack sealing the roads in the areas that will be chipped sealed this year. They are continuing with lawn cutting and maintaining the fields. They are making progress with separating materials at the dirt pile on Long Meadow Rd. On June 15th an excavator and screener will resume the work at the dirt pile left off from last year. The test results from Phase 1 will be finalized soon. The Watchtower group have agreed to help with the cleanup and will begin somewhere between June 1th and September.

DISCUSSION ITEMS:

Fee Schedule Amendments and Civil Penalty Amendments

Attorney Protter explained the goal is to end up with an approved list of fees for the Building Department. Currently there is a local law that allows fees to be amended by resolution, but a new fee category cannot be added. The current local law has to be amended to add new categories of fees. The new categories being proposed are reinspection fees and for permits being issued after work is completed. The next step is to amend the local law and then establish fees for the new categories. There are two local laws being proposed; one is adding the categories of fees and the other is to add civil penalties.

The Town Board agreed to schedule the Public Hearing for both local laws.
